February 2026 Meeting



EQIP

- Eligibility will need to be submitted by February 20th.
- We are working through the eligibility and assessments on the applicants that requested to be deferred to 2026.
- We have a new cost list that is very confusing and doesn't have some of the practices that we normally fund. This is a national cost list instead of an area one like we are used to.

Water Smart Program

- Adam has been working with these applicants to finish up eligibility and assess them.

CSP

- Has the same deadlines as regular EQIP this year.

RPP

- New initiative for 2026 25% of our total EQIP and CSP allocation
- Required minimum 5 year contracts – whole farm/ranch planning
- Requires soil testing by a qualified individual in year 1 and year 5 of contract
- Requires a primary practice be scheduled on one land unit. Secondary practices can be scheduled if they benefit or are needed to make the primary practice work.

CTA (Conservation Technical Assistance)

- Taking new applications and making field visits on those.
- Fairly caught up with the backlog of payments, modification, and other documents from the shutdown.
- Assisted producers who called or e-mailed with Field visits for RC concern issues and questions about programs and projects.

Other

- The new structure for the accounts under the programs was sent out. Each state is limited to 5 Ranking pools (WY choose to offer 4 with categories under them) Rocky Mountain, High Plains, Water, Wildlife. Funds can be moved around within these as needed.
- Rocky Mountain and High Plains will each get \$10,096,250 and have these categories.
 - Cropland
 - Livestock (Range/Pasture/Headquarters)
 - Forest
 - High Tunnels
 - WRIR
 - Regenerative Pilot Program
 - SDFR
 - BFR

- State Water Account will be allocated \$5,470,000 have these categories
 - WME (Water Management Entity)
 - Wetland and Fish Habitat
 - Source Water Protection – Fremont
 - Source Water Protection – Goshen

- State General/Wildlife Account will be allocated \$417,256,632 and have these Categories.
 - Joint Chief’s Landscape Restoration Initiative
 - Migratory Big Game Initiative
 - Sage Grouse Initiative
 - NWQI (Multiple Categories)
 - WaterSMART (Multiple Categories)
 - Colorado River Salinity
